INTRODUCTION

- Gujarat State Watershed Management Agency (GSWMA) is the nodal Agency for implementation of Integrated Watershed Management Programme (IWMP) in the Gujarat state and its mandate includes planning for and development of all the watersheds of the state either directly or indirectly.

OBJECTIVES

The main objectives of the Department are:

- The basic objective of this scheme is an integrated wastelands development based on village/micro watershed plans. These plans are prepared after taking into consideration the land capability, site condition and local needs of the people.
- The scheme also aims at rural employment besides enhancing the contents of people's participation in the wastelands development programmes at all stages, which is ensured by providing modalities for equitable and sustainable sharing of benefits and usufructs arising from such projects.



ACTIVITIES

The major activities taken up under the scheme are:

1. In situ soil and moisture conservation measures like terracing, bunding, trenching, vegetative barriers and drainage line treatment.
2. Planting and sowing of multi-purpose trees, shrubs, grasses, legumes and pasture land development.
3. Encouraging natural regeneration.
4. Promotion of agro-forestry & horticulture.
5. Wood substitution and fuel wood conservation measures.
6. Awareness raising, training & extension.
7. Encouraging people's participation through community organization and capacity building.
8. Drainage Line treatment by vegetative and engineering structures
9. Development of small water Harvesting Structures.
10. Afforestation of degraded forest and non forest wasteland.
11. Development and conservation of common Property Resources.



ROLE OF UNNAT BHARAT ABHIYAN PARTICIPATING INSTITUTE

- **Step 1:** Visit and meeting with District Project Manager of IWMP Department at **District Rural Development Agency (DRDA)**
- **Step 2:** Get knowledge on scope of work and implementation process of IWMP
- **Step 3:** Conduct surveys and identify the need of IWMP in UBA adopted villages.
- **Step 4:** Work with Gram Panchayat & IWMP Department, DRDA Office for implementation of watershed development & management works.
